NO ADDITIONAL OR HIDDEN COSTS. IF YOUR ACDELCO BATTERY IS FOUND DEFECTIVE UNDER NORMAL USAGE, YOUR INSTALLER WILL PROVIDE A REPLACEMENT BATTERY AT NO CHARGE TO YOU.

#### THE PLAN

This plan covers the following BCI groups of ACDelco Professional five, six and seven year batteries: 24, 24R, 25, 26, 26R, 27, 27R, 34, 35, 41, 42, 45, 48, 49, 51, 51R, 55, 58, 58R, 62, 64, 65, 70, 74, 75, 76, 78, 85, 86.

The purpose of this plan is to extend the no-charge portion of the original manufacturer's 5, 6, or 7 year warranty so that there is not a cost per month charge to the end user over the entire warranty period shown on the front side of the extended warranty form.

#### TERMS AND CONDITIONS

Throughout the replacement plan the words "we", "us" and "our" refer to the installer or merchandiser who sold the battery to you and does not include ACDelco in any way whatsoever. The words "you" and "your" refer to the purchaser of the battery.

#### TO OBTAIN YOUR REPLACEMENT BATTERY

Return the vehicle if your battery was installed by the seller, or just the battery if you installed it yourself. Bring the extended replacement warranty form along with your original purchase receipt and we will replace your ACDelco battery at no-charge to you during the specified number of years listed on the warranty replacement form.

#### REPLACEMENT COVERAGE

- This plan provides for replacement of the covered battery found to be defective by us.
- Our limit of liability is for the value of the battery only.
- All plan coverage commences on the original purchase date.
- This plan covers manufacturer's defects in materials and workmanship, however this battery's Extended Warranty is the responsibility of the warehouse distributor and the installer and is not warrantied by ACDelco.
- The battery failure must be due to normal usage.
- This plan is inclusive of the manufacturer's warranty.
- This plan is not transferable from the original owner/purchaser.
- This plan does not cover batteries that are used for commercial or marine purposes.
- This plan does not cover replacements necessitated by accidental or intentional physical damage, misuse or non-authorized installation or repairs.
